# 7. How much can I expect to earn if I complete this program and obtain employment in the Health Administration field?

Applicant participants who complete this program are qualified for a variety of entry-level positions in various healthcare settings. Those that complete the program may obtain employment as a Health IT Support Analyst, HIT and EHR Analyst Data Analyst, Healthcare IT Manager, Health Informatician Healthcare AI Strategist, Healthcare IT Support Medical Ethics Specialist, Help Desk HIPAA Privacy Officer, Healthcare IT Manager, Health IT Support Analyst, Data Analyst or similar roles in back office or information technology roles. The average compensation for workers in these occupational roles is generally \$40.000 \$60,000 plus benefit packages, and additional training opportunities. These positions are attainable with a high school education, work experience and an understanding of healthcare fundamentals and demonstrated soft skills.
