## STATEMENT OF THE CASE

On January 9, 2008, Jesse Wyatt (Complainant) filed a complaint with the Maryland Home Improvement Commission (MHIC) regarding the actions of Glenn Bailey, t/a DB Flatworks (Respondent). Based upon his complaint and after an investigation, the MHIC filed regulatory charges against the Respondent on October 20, 2010.

The MHIC transmitted the case to the Office of Administrative Hearings (OAH). I conducted a hearing on April 13, 2011 at the Largo Government Center in Largo, Maryland, pursuant to the Business Regulation Article section 8-312. Hope Sachs, Assistant Attorney General, represented the MHIC. The Respondent failed to appear after being properly notified.
