FINAL ORDER

On this 1ST day of March , 2017, Panel B of the Maryland Home Improvement Commission ORDERS that:

- 1) Pursuant to Business Regulation Article, §8-408(b)(3)(i), Annotated Code of Maryland, the Claimant has provided the Commission with a copy of a final award in arbitration, dated July 8, 2016, with all rights of appeal exhausted, in which the arbitrator found on the merits that the conditions precedent to recovery, as set forth in Business Regulation Article, §8-405(a), Annotated Code of Maryland, have been met, and found that the Claimant sustained an actual loss of \$37,074.04, as the cost to complete work which was not performed by the Respondent. (The arbitrator issued a total award of \$45,149.04 in favor of the Claimant.)
- 2) Pursuant to Business Regulation Article, §8-405(e), Annotated Code of Maryland, the maximum recovery permitted for a claim against the Home Improvement Guaranty Fund is \$20,000.00.
- 3) The Commission directs payment of \$20,000.00 from the Home Improvement Guaranty Fund to the Claimant, Doguhan Uluca.
