Executive Director's Report

Mr. Thomas and Ms. McCollum confirmed that they would attend the CIDQ Annual Meeting scheduled for November 10 and 11, 2023, in Louisville KY. Mr. Thomas provided additional information to the Board about correspondence he received from CIDQ regarding bylaws and restructuring of the CIDQ Board from the current board structure of 8 members (president, president-elect, past president; 4 at-large directors, and 1 public member) to a 9 members board structure (president, president-elect, past president, and 5 at-large directors, and 1 public member).

Chair Dubick and Ms. Sneed both shared an overview and some details on what to expect during the Annual Meeting. Ms. Dubick explained the criteria and qualifications for new CIDQ Board members as well as the changes that might affect some of the Council's Board positions.

2024 CIDQ Board of Directors ballot

Chair Dubick expressed being positive about the slate of candidates that the CIDQ proposed.

Mr. Daly updated the Board that the CIDQ Model Law would be finished this year. He is optimistic about getting it distributed to the various Boards, which would be helpful to other jurisdictions.

Ms. Sneed mentioned that OTJ Architects in Washington, DC is sponsoring a scholarship fund. This scholarship fund is intended specifically for Black/African-American architects and interior designers to help supplement their ARE and CIDQ exam costs. She stated that additional information will be forwarded to the Board.

Residential Interior Design

Ms. Frazier indicated that the fledgling residential design certificate program at Morgan State University has been discontinued. The School of Architecture and Planning will continue to offer the Bachelor of Science in Interior Design (INTD).

Designation of CID Committee

Chair Dubick apologized for not sending the draft of the CID Board's designated committee members but confirmed that it would be circulated.

CIDQ Annual Meeting Attendance

Chair Dubick reiterated that Mr. Thomas and Ms. McCollum will be attending the Annual Meeting in November on behalf of the MD CID Board as discussed earlier under the Executive Director's report.
