New Business

Amendment to COMAR 09.19.08.02

Commissioner Troxell, Chairman, addressed the Commission to propose an action to amend COMAR 09.19.08.02 to remove outdated incorrect language regarding reciprocal licensing pertaining to real estate

appraiser reciprocal licensing. The outdated language was discovered by the Appraisal SubCommittee during a recent audit.

A Motion was made by Commissioner Pickholtz, seconded by Commissioner Harman and by a majority vote carried that the Commission Propose an action to amend COMAR 09.19.08.02 regarding reciprocal licensing for real estate appraisers. Commissioner N'namdi abstained.

Amendment to COMAR 09.36.06.01G and 09.36.08.02

Commissioner Troxell, Chairman, addressed the Commission and requested proposed action to amend COMAR 09.36.06.01G and 09.36.08.02 for all home inspectors to obey all federal and state laws and regulations and local ordinances and to amend certain criteria pertaining to home inspector continuing professional competency ("CPC") education.

A Motion was made by Commissioner Pickholtz, seconded by Commissioner Oslund and, by a majority vote, carried that the Commission propose action to amend COMAR 09.36.06.01 and 09.36.08.02 to require a licensed home inspector to obey all federal, state, and local laws, regulations, and ordinances; and comply with CPC requirements, respectfully. Commissioner N'namdi abstained.

Counsel will prepare and submit the proposed actions to the AELR Committee for review and, subsequently, for publication in the Maryland Register., and will provide status updates to the Commission, as necessary.

Chairman's Report

Commissioner Troxell, Chairman, welcomed new Commissioners Kabir and N'namdi to the Commission and thanked them for volunteering.

Assistant Attorney General's Report

Sloane Kinstler, Assistant Attorney General, welcomed and thanked Commissioners Kabir and N'namdi for their service and stated that she looked forward to working with them.

Executive Director Report

Executive Director Blackistone addressed the Commission to welcome Commissioners Kabir and N'namdi and expressed his gratitude for their inclusion. Mr. Blackistone also reminded the Commission about the Department of Labor's relocation to 100 South Chares Street expected on or about October 2024.
