**CONSENT ORDER**

This matter comes before the Maryland Real Estate Commission ("Commission") as the result of a complaint filed by Monica Davis and Ethel Davis ("Complainants"). Based on the complaint and an investigation, the Commission determined that administrative charges against the Respondent, real estate broker, Charles R. Klein, affiliated with RE/MAX Allegiance, license registration number, 01-31417 ("Respondent"), are appropriate and that an administrative hearing on those charges should be held.

To resolve this matter without a formal hearing, the Commission and the respondent have agreed to enter into this Consent Order to provide for the imposition of disciplinary measures which are fair and equitable in these circumstances and which are consistent with the best interest of the people of the State of Maryland. The Commission and the Respondent agree and stipulate as follows:

1. At all times relevant to the matters set forth in this Consent Order, the Commission has had jurisdiction over the subject matter and the Respondent.
2. The Respondent was, at the time of the event at issue, affiliated with RE/MAX Allegiance, as a broker, license registration number 01-31417.
3. The Complainants allege she retained Ms. Sarr, a salesperson, affiliated with Respondent to represent her in the sale of a home in Bowie, Maryland.
4. It is further alleged that Respondent failed to adequately supervise Ms. Sarr when she failed to provide a written Addendum extending the listing agreement when the original listing agreement expired.
5. The Respondent admits that by failing to provide adequate supervision to the Ms. Sarr he has violated COMAR 09.11.05.021 (A) which provides:

(A) A broker shall exercise reasonable and adequate supervision over the activities of the broker's associate brokers and salespersons.

6. The Respondent consents to the entry of an Order that his conduct, as described in this Consent Order, violates COMAR 09.11.05.02 (A) and he consents to the imposition of a Reprimand against his real estate salesperson license registration number 01-31417.
7. By entering into this Consent Order, the Respondent, expressly waives the right to an administrative hearing on the charges, the making of Findings of Facts and Conclusions of Law, any and all further proceedings before the Commission to which the Respondent may be entitled in this matter and any rights to appeal from the Commission's Order.
8. The Commission accepts this Consent Order as the full and final resolution of Complaint No. 604-RE-2016 GF.

**BASED ON THESE STIPULATIONS, IT IS THIS 16<sup>TH</sup> 9<sup>TH</sup> DAY OF NOVEMBER, 2016 BY THE MARYLAND REAL ESTATE COMMISSION.**

**ORDERED** that the Respondent violated COMAR 09.11.05.02 (A) by failing to provide adequate supervision over the duties of an salesperson affiliated with his brokerage; and it is further

**ORDERED** that the Respondent have a Reprimand placed against his real estate broker's license registration number 01-31417, and it is further
